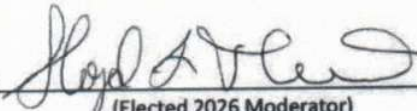

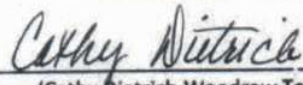
12) No new business from floor
